SUBJECT: 2024 District 3 Agriculture Product Identification Contest

When: Thursday, Dec 5, 2024

Where: Young County Arena 120 Barclay Blvd, Graham, TX

Time: Registration will begin at 9:00am.

Lunch will be sponsored for 4-Hers and volunteers in attendance by Capital Farm Credit.

Entries will be on 4-H Online at a fee of \$15.00 per youth. Registration will be open from September 1 – November 13, 2024. Late registration will be November 14-21, 2024, for a late fee of \$25.00 **PLUS** the \$15.00 per youth.

After this time, no more late registrations will be accepted. You will NOT be able to register or pay the day of the contest for the District 3 4-H Contest.

There will be 3 divisions with awards for each division:

The top 3 teams in each age division will receive award banners. The high point individuals in each age division will receive a belt buckle. The 4th and 5th place teams will receive ribbons.

AGE: The AG ID Contest is open to enrolled 4-H members 3rd grade through 12th grade.

Age Divisions are:

- Junior Grades 3-5
- Intermediate Grades 6-8
- Senior Grades 9-12

This contest is for teams and individuals. Teams will consist of 3 or 4 members with the 3 highest scores being counted toward team totals. Agents/Coaches will designate teams at registration. Please have your teams set to expedite the beginning of the contest.

The contest will consist of up to 30 products that will be identified from four possible choices. Each station will also have a multiple-choice question pertaining to the product on display. Youth will be given 30 seconds at each station to answer both questions. Products may be chosen from any of the resources listed in the Agriculture Products Identification study guide.






